

New Student Fees

Application Fee, per family: \$75 (non-refundable)

Registration Fee, per student: \$300 (non-refundable*)

*Exception: Registration fee and all completed paperwork guarantees student placement if a seat is available. If no seats are available for new student, the registration fee and all completed paperwork guarantees a spot on waiting list. If the seat applied for does not become available, the registration fee can be refunded for waitlisted applicant upon written request received no later than September 17, 2012.

Returning Students

Re-Enrollment Fee, per returning student, due by February 10, 2012*: \$125 (non-refundable)

Curriculum Fee, per returning student, due by June 15, 2012: \$175 (non-refundable)

* There will be a \$35 late charge for any fee paid after due date

Additional Discounts

Pre-pay by June 15, 2012 by credit card for a 5 percent discount.

Oldest child tuition follows chart above. The second and third child receives a 10 percent discount. The fourth child and beyond receives a 20 percent discount. (Sibling discount does not apply to 3-day Pre-K).

Important Information

Credit Card Prepayment and Enrollment Fee Option—CCS accepts VISA/MASTERCARD/DISCOVER credit card payments for tuition when paying in full by June 15, 2012 (5% discount), as well as re-enrollment and registration fees.

Monthly Payment Option—All families who are currently enrolled in the monthly payment option will be automatically re-enrolled in the automatic deduction option of the FACTS Tuition Program which deducts payments directly from your bank institution. Payments run on a ten-month cycle (August 5, 2012 through May 5, 2013 or August 20, 2012 through May 20, 2013). There is an annual \$41 FACTS enrollment fee (assessed by the FACTS Corporation) which will be automatically deducted 14 days after you receive your confirmation letter from FACTS. The FACTS Corporation assesses a \$35 fee on all returned payments.

Returned Checks—All returned checks will incur a \$10 fee.

Delinquent Accounts—Families with delinquent accounts cannot re-enroll until all financial obligations have been met. Tuition account must remain current through the end of the year in order to maintain enrollment status. Any accounts more than 30 days past due are subject to suspension of enrollment.

Withdrawn Students—Families withdrawing from CalvaryChristianSchool must do so in writing indicating last day of school attendance and are responsible for the full month's tuition corresponding to the withdrawal date. Student's records will be held until all financial responsibilities have been met. Written requests to be relieved of month's financial responsibility due to unforeseen circumstances must be presented to the CCS Administration.

Before/After Care Information—Cost is \$2.50 per ½ hour or any part thereof. There is an annual fee of \$20 per family assessed at time of first use.
